GENERAL PHOTOGRAPHY CONTRACT

1. Fees

In consideration for the photography services provided by the Photographer, client agrees to pay a non-refundable Session Fee in the sum of _____, which is 50% (fifty-percent) of client's chosen Package, and due at the time this contract is signed to secure Session and current prices. This fee also covers the time to prepare for the shoot, our conversations, scouting your chosen location(s), post-processing/developing of images, and Package product processing.

The remainder of the Package Fee shall be paid upon the completion of the shoot. If client is ordering from the Photographer's Artisan Add-On's, half of the order total is due upon ordering and the remainder due at delivery. Client is responsible for covering additional fees and costs related to location choice (admission fees, parking, etc). 50 miles of travel from 61321 is included in all Packages. Time and travel above this will be invoiced (contact me for pricing – can vary due to fuel charges). All payments can be made with Cash, Cashier's Check from a bank or credit union, or a Credit Card. Credit Card usage comes with a 5% fee. No personal checks accepted.

2. Session

Because it can be a distraction (especially to small children) and prevents the photographer from being able to do her job effectively, other cameras are not allowed at the photo session. Also, please bring only the people who will be photographed to the session. Too many people are often distracting especially to small children. Clients' child's focus should be on the photographer in order to get the best images.

Photographers never want to photograph someone who isn't feeling 100%. If someone becomes ill, Client should call as soon as possible to reschedule. Remember the deposit is not refundable. The Photographer maintains the right to reschedule if needed due to inclement weather, illness, emergency, etc. Requests for rescheduling or re-shoots are granted only at the Photographer's discretion. If the Photographer fails to appear at the place and time specified above, the deposit shall be refunded to the Client.

Please remember the photographer keeps a schedule. It is very important that the Client arrives at the scheduled time. If Client will be late, please call the Photographer at 309-363-8628. If Client arrives more than 15 minutes late without a phone call, the Photographer reserves the right to reschedule. Client's session is to be the best it can, along with any sessions scheduled afterwards.

The Client shall assist and cooperate with the Photographer in obtaining the desired photographs, including but not limited to specifying persons and/or scenes to be photographed; taking time to pose for photographs at the Photographer's direction; pre-shoot consultations, etc. The Photographer shall not be responsible for photographs not taken as a result of the Client's failure to provide reasonable assistance or cooperation.

3. Proofing & Ordering

Photographer will perform basic post-processing or digital image editing services on these photos where artistically and developmentally necessary.

Creative privilege is reserved for times when an image needs a certain crop or a particular treatment. The Photographer will do her best to match the Client's taste, but freedom is needed to decide how to make an image look its absolute best.

Client's images will be available in a password protected Online Gallery approximately 14 days following the shoot. If necessary, the Photographer reserves the right to utilize more time. Client understands and agrees that proofs are the exclusive property of the Photographer and Client has no right to these images except for a license to review them, but not store the proofs.

Client will receive 10-15 more images than listed in the client's chosen portrait Package. Client will have access to the Gallery for 21 days. At that time Client should be prepared to choose the images to complete their already chosen Package. An additional charge of \$25 will apply to view the Gallery for an extra 7 days.

After careful inspection, Client will inform the Photographer of their image choices to complete their Package and order any Add-On's. Client should be prepared to choose images during the 28-day period when the Gallery is posted. This is strictly to maintain a speedy workflow and to help prevent backlogging for other Clients. Images not chosen within 28 days will be archived and after 56 days, destroyed. There will be a \$25 charge added for images chosen after 28 days.


If the Client has a request for small changes to an image, the Photographer should be notified when choosing the images. The Photographer can address minor changes at no cost (fix blemishes, tighter crop, etc.) but more involved requested are billed at \$55 per hour, half the Photographers normal hourly rate of \$110. The Photographer will let the Client know if there will be extra charges before work begins. Once the requested changes are made, charges apply regardless if the final product is purchased.

The Photographer will send Client's Package order to the Lab once full payment is received (minus any Artisan Add-On's remainder) and begin creating any Artisan Add-On's ordered. Once that order is completed the balance of the total fee is due at delivery. If the remainder cannot be paid, the Add-O's will not be delivered and held by the Photographer until the balance is paid. The Photographer is not liable for coloring errors, print quality or cropping of any images printed from the Lab. All sales are final.

Digital Images will be provided to the Client on a basic USB drive. Client has no rights or license to these images. Digital Images are to ONLY be shared digitally, such as on Instagram, Facebook, other Social Media, etc. Images will have the Photographers watermark. All images are for personal use only, no monetary use is allowed.

Artisan Add-On's may or may not be available when the Lab order is delivered to the Client. The Lab order will be delivered no later than 28 days after the Photographer has sent the Package order to the Lab. The Photographer reserves the right to take as much time as necessary for her Artisan Add- On's creations.
